Responsibilities

GIZ in cooperation with SADC Secretariat is seeking an experienced expert from the SADC Region who will:

- Advise SADC Secretariat on the implementation and monitoring of SADC LEAP (Law Enforcement and Anti-poaching Strategy) by;
 - Liaising with all relevant SADC Directorates, specifically FANR and ORGAN, on the implementation of the LEAP strategy
 - Assisting SADC Secretariat in its mandate to support Member States in the adaptation and adoption of LEAP strategy;
 - Assisting SADC Secretariat and GIZ in the establishment of a SADC TWIX (Trade in Wildlife Information eXchange)
 - Assisting SADC Secretariat and GIZ in coordinating the implementation of other key activities in the LEAP Strategy;
 - Assisting SADC Secretariat and GIZ in the preparation of anti-poaching and IWT (Illicit Wildlife Trade) related documents and positions for relevant regional and international fora, especially the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES)
 - Support SADC and GIZ in organising regional workshops, events, meetings related to adaptation and adoption of the LEAP strategy
 - Monitoring and reporting on anti-poaching activities and policies in SADC Member States
 - Liasing with other International Coordinating Partners (ICPs) to increase donor coordination and mobilize funds for implementation of the LEAP strategy
 - Liaising with GIZ HQ based Partnership against Poaching and Illegal Wildlife Trade Programme and contributing to its knowledge management
 - o Liaising with other pertinent GIZ Programmes in the Sub-Region
 - Liaising with key stakeholders in Member States in the fight against poaching and IWT
- Follow, analyse, summarize and share all relevant information related to anti-poaching and IWT in the Sub Region
- Compile reports as required / applicable
- Initiate, develop and maintain professional relationships with relevant actors and decision makers and cooperate with these

Qualification and Professional experience

- MSc or PhD degree or equivalent in Public Policy; Law; Economics; Wildlife Management or Natural Resources; or related field;
- Citizen of SADC or Permanent Resident in the SADC region (with valid work permit)
- Long term working experience in developing policies, or strategies related but not restricted to the field of sustainable natural resource management, law enforcement related to illegal wildlife trade and anti-poaching and/or trade in wildlife species products
- Good knowledge of the SADC region and issues pertaining to poaching and illegal wildlife trade in Southern Africa;
- Understand the interrelationships between poaching, sustainable and economic management of natural resources, illicit financial flows and the political economy of poaching/ anti-poaching and illegal wildlife trade
- Demonstrate a bias free perspective on the different positions member states hold on topics such as trophy hunting, ivory stock pile management, etc.
- Appreciate the role of communities in wildlife management and translate such understanding into suggestions for policy options.
- Experience in strategic planning, programme/ project and/or policy formulation
- Excellent interpersonal relations and communications skills and ability to present complex subjects in simple manner to a variety of audiences
- Excellent writing and speaking skills in English, Knowledge of French, Portuguese or German is an added advantage;
- Willing, able and legally permitted to travel frequently, occasionally ad hoc, within the region and occasionally to countries outside SADC.
- Good understanding of multilateral environmental agreements (MEAs) related to illegal wildlife trade and anti-poaching
 - recognize the political sensitivity of the subject, act diplomatically but also be able to facilitate/ moderate Member States, without bias, to develop common positions on controversial topics of illegal wildlife trade and anti-poaching/poaching.
 - demonstrate a bias free perspective on the different positions member states hold on topics such as trophy hunting, ivory stock pile management, etc.
